Universities play an increasingly important role in the field of human rights: in terms of academic formation and human rights education for students; as places of interdisciplinary research and academic think-tanks as well as in the field of policy advice.

Human rights do not only constitute one of many topics in academic research, but also a responsibility of the university as an organization. Currently, **Universities are human rights actors** in different capacities. Through the course of the past years they have given different institutional answers to the challenges posed by human rights, such as instating professorial chairs dedicated to human rights, establishing human rights institutes and interdisciplinary research centres as well as inaugurating specific human rights studies.

For many years, intensified engagement is what has been asked of scholarship and universities by international institutions. In accordance with the aims of the United Nations, knowledge of the basis and objectives of human rights should constitute an integral part of all University studies. That way, after graduating, everybody would have the capacity to implement human rights in his/her professional and social environment

This crystallized in the vision of a utopian "Human Rights University" (Barnett/Guzman) which links the universal character of human rights with the idea of the university as a cognitive space in society that deliberately engages in the wider

world and takes a stance on the advancement of human rights within its own structures and beyond.

Given current challenges to human rights, such as the recent refugee crisis, also the importance of Universities as human rights agents is likely to increase. At the same time, human rights education and research at Universities faces important challenges and obstacles, not the least in view of financial and institutional constraints.

As source for reflection on social development, but also in their role as "generators of knowledge", Universities have a special responsibility to also critically reflect about their own teaching and research practice.

In all these initiatives Manfred Nowak has played a leading role at the University of Vienna and in many other academic and non-academic settings. The University of Vienna acknowledges human rights as cross-cutting issue in academia and Manfred Nowak and his team have truly transformed it into a human rights actor.

This symposium, in honour of Manfred Nowak, proposes to take an internal as well as an external view on the University as human rights agent. It intends to look at the above questions from "The Inside" as well as from "The Outside". In order to do this, it unites distinguished academics as well as highlevel practitioners to discuss the place of Universities as human rights agents.
