Are you interested in universities' social responsibility? Would you like to know more about university-business cooperation or how researchers can approach NGOs?



University of Barcelona – Learning from the Office for CSR

The University of Barcelona can be considered a pioneer university when it comes to corporate social responsibility. It created a dedicated office in 2009, which is in charge of monitoring activities and projects linked to the university's social responsibility. We interviewed *Maurici Romero Mulero*, Head of the Office for Internal Control, Risks and Corporate Social Responsibility.



Mulero: "One of the main task of our Office is to prepare an annual report on social responsibility following the guidelines of the Global Reporting Initiative (GRI) and the functions that the UB's Committee for Social Responsibility assigns to us. The UB Committee for Social Responsibility is a political body with representatives of various stakeholders (society, students, workers, managers, the Rector, unions, etc.). Currently we are in charge of several projects:

- The UNIBILITY project
- Adaptation of the Economy for the Common Good to the UB
- Adaptation of GRI indicators to the context of a higher education institution

- Incorporation of social and environmental clauses in the procurement of services and purchases of goods by the UB
- Code of Social Responsibility (pending approval by the UB's governing team)."

2. "Why was the office founded?"

Mulero: "The Office was created in 2009 with the arrival of the current rector Dídac Ramírez to strengthen the efficient use of university funds and to strengthen social responsibility in our university. In the elections for the Rector's Office in 2008 social responsibility was a central tenet in the management system proposed by Dídac Ramírez, who was finally the winning candidate. As a result of this commitment he decided to create the Office."

3. "What can you recommend to other universities who are planning to establish such an office?"

Mulero: "Considering that it would be a new office and that it would be necessary to collect a lot of accurate information from different people and administrative units:

- The head of the office should be a person with a holistic perspective and global knowledge of the organization.
- The head of the office must have effective capacity within the

- organization in order to have his demands met properly and on time.
- The involvement of the university government is required. USR has to be a basic strategic area and its importance has to be displayed within the university community. Doing this, the administrative units will understand that the requests made by the social responsibility office are important and must be dealt with promptly. "
